<b>Class of consumers in the target market</b>	The product has been designed for consumers who:  <b>Term Deposit;</b> Consumers who need the certainty of a fixed rate of interest on their savings and do not need the ability to withdraw funds at call prior to maturity of the deposit or need regular monthly income even it that means a lower rate of interest or need to maximise the interest rate payable and will accept interest at maturity.
<b>Product description, key attributes, and eligibility criteria</b>	<b>Product description including key attributes</b>  This is a <b>Term Deposit;</b> <ul style="list-style-type: none"><li>▪ Minimum \$2,000- opening deposit.</li><li>▪ Investment terms range from 3 months to 24 months.</li><li>▪ Fixed interest rates for the selected term which are tiered depending on the amount invested.</li><li>▪ Interest is calculated daily and paid monthly, at maturity or annually.</li><li>▪ Automatic rollover available.</li><li>▪ Regular monthly income, standard and compound interest types available.</li><li>▪ Early withdrawal available but subject to penalty.</li></ul> <b>Product's eligibility criteria</b> The product's eligibility criteria is: Product eligibility is subject to meeting the Term Deposit criteria of Woolworths Team Bank.
