INSTRUCTIONS FOR COMPLETING THE 2024 PROXY FORM

1. YOUR MEMBER NAME, MEMBER NUMBER AND CONTACT DETAILS

Please input your name, membership number, address and contact (daytime) phone number. Your membership number is printed on your account statements and on the bottom of the credit and debit cards.

2. APPOINTMENT OF A PROXY

If you wish to appoint the Chair of the Meeting as your proxy, mark the box with an "x" where indicated. If the person you wish to appoint as your proxy is someone other than the Chair of the Meeting, please write the name of that person in the box opposite. If you leave this section blank, or your named proxy does not attend the meeting, the Chair of the Meeting will be your proxy. A proxy need not be a member of Woolworths Team Bank Limited.

3. VOTING ON THE SPECIFIED AGENDA ITEM

You may direct your proxy on how to vote by placing a mark (*mark with an "x"*) in one of the three boxes opposite each item in respect to Agenda Items 5 and 6. If you do not mark any of the boxes, your proxy may vote as he or she chooses. If you mark more than one box in respect to each person, your vote on that person will be invalid.

If you mark the "Abstain" box, you are directing your proxy not to vote on your behalf on a show of hands or on a poll and your vote will not be counted in ascertaining the required majority on a poll when relevant.

4. SIGNING INSTRUCTIONS

You must sign the Proxy Form as follows - where relevant - in the spaces provided:

Individual	Where the membership is in one name, that person must sign.
Joint Holding	Where the membership is in more than one name, all of the joint members should sign. However, if not all joint holders are available to sign, then the first named joint holder must sign.
Power of Attorney	To sign under a Power of Attorney, you must have already lodged the Power of Attorney with the Bank. If you have not previously lodged this document for notation, please attach a properly executed letter or certification confirming appointment to act as a Member Representative to the Proxy Form upon its return.
Company Member	Where the company has a sole Director who is also the sole Company Secretary, the Proxy Form must be signed by that person. If a company does not have a Company Secretary, a sole Director can also sign alone. Otherwise, the Proxy Form must be signed by a Director jointly with either another Director or a Company Secretary. Please indicate the office held by signing in the appropriate place.
