Cashback Offer Terms and Conditions

- 1. This Online Cashback Offer ("Offer") is provided by Woolworths Team Bank Limited ACN 087 651 803 of 522-550 Wellington Road, Mulgrave VIC 3170.
- 2. This Offer is available between 15 December 2025 and 28 February 2026 ("Offer Period").
- 3. This Offer is open only to Australian permanent residents aged 18 years and over ("Eligible borrower").
- 4. Participating in the Offer is automatic and constitutes acceptance of these Terms and Conditions.
- 5. Under the Offer, a payment ("Cashback") will be paid to the Eligible borrower where all the following conditions are met:
 - An eligible loan application is submitted to Woolworths Team Bank, including the completion of verification of identity; and
 - The loan applied for is approved and funded by 31 May 2026.
- 6. The cashback payment amount is a single payment of \$3,000.
- 7. To be considered an eligible loan, all the following criteria must be met:
 - The loan purpose is refinancing a secured home loan from another financial institution;
 - The loan-to-value ratio (LVR) is less than or equal to 80%;
 - o The minimum loan amount is \$500,000;
 - The loan is for a variable owner-occupied or variable residential investment loan.
- 8. Where there are joint borrowers applying for a residentially secured home loan, only one cashback will be paid per eligible loan.
